FIELD DAY WITH MONTAUK YOUTH

EDUCATION AND ADVOCACY

IS MILLSTONE A THREAT TO MONTAUK?



Concerns about the 40-year-old Millstone Nuclear Power Station in Waterford, Conn., have been sharpened since the earthquake and tsunami in Japan earlier this year triggered a major nuclear disaster at the Fukushima, Daiichi, power plant. The aging Millstone plant is just 20 miles from Montauk across Long Island Sound – closer to us than the Bridgehampton Commons and far closer than the Shoreham nuclear plant, which was shut down in the face of strong community resistance.

How much of a threat does Millstone pose to Montauk and the East End? Investigative journalist Karl Grossman and County Legislator Jay Schneiderman tackled this question at CCOM's Annual Meeting in September.

THREATS AND REGULATIONS

Both speakers discussed the two emergency planning zones that the Nuclear Regulatory Commission has established around nuclear power plants: a "plume exposure pathway zone," with a radius of 10 miles, dealing primarily with exposure to airborne radioactive materials, and an "ingestion pathway zone" of about 50 miles, concerned mainly with ingestion of contaminated food and liquid. Around Millstone, the reach of these zones is broad – 125,000 people live within a 10-mile radius and nearly 3 million live within 50 miles. The U.S. federal government requires a standard evacuation zone of just 10 miles. However, as the Fukushima disaster proved, this is inadequate. Noting that the U.S. Government urged U.S. citizens within a *50-mile* radius of Fukushima to evacuate, Schneiderman is calling for expansion of Millstone's 10-mile evacuation plan to a minimum of 25 miles, which would include all of Long Island's East End.

Grossman and Schneiderman believe that any catastrophic event at Millstone would be devastating to Montauk. Millstone could be compromised not only by natural disasters, but by terrorism and human error, Schneiderman said. Pointing to the higher rates of cancer near nuclear power plants – a fact many attribute to routine emissions – Grossman emphasized that even without a catastrophe, nuclear power has risks.

WHAT CAN BE DONE?

While other countries moved away from nuclear power after the disaster in Japan, the U.S. response was a review of the 104 plants spread around the country. Although federal inspectors cited Millstone for operating at capacities far beyond those permitted, there has been no reconsideration of the recently extended license, which will permit two of the facility's three reactors to operate for an additional 20 years.

Given that evacuation of the East End would be impossible in the event of a nuclear disaster, Schneiderman says that there should be no choice but to shut Millstone.

NEIGHBORHOOD FOCUS

Here are some highlights of what CCOM's professional staff, volunteers and dedicated Board of Directors have been up to this fall. Visit PreserveMontauk.org or follow us on facebook to learn more.

1 FORT POND HOUSE PARK

After more than a year of deliberate delays intended to avoid a trial, attorneys representing East Hampton Town have finally been forced to answer CCOM's Petition asserting the Town acted illegally in attempting to sell public parkland. The case has now moved to the discovery phase and the submission of arguments to the court. If needed, the court can order a trial.

2 FEE DOCK PROPOSAL

Common sense – and the environment – prevailed when the Zoning Board of Appeals agreed that having a picture of a dock from decades ago is not the same thing as having a dock today. Citing the potential for nearly 150 new residential docks on Lake Montauk alone if the flood gates were opened, CCOM urged the Board to move very carefully as it weighed the meaning of the phrase "pre-existing dock" and to require that any dock applications comply with the Town Code.

10 41ST ANNUAL MEET THE CANDIDATES

A packed room listened to debate about protecting Montauk's environment, quality of life, code enforcement, Town finances and more. Story and photos, pg. 7.

9 SURF LODGE

After years of operating in violation of the Town Code, the owners of the Surf Lodge nightclub have finally been forced to seek some solution to the hundreds of violations that have raised concerns from a broad range of neighbors, civic and environmental groups, including CCOM. Because Surf Lodge's septic systems are not capable of keeping their effluent out of Fort Pond, CCOM has met with the Suffolk County Health Department to bring their attention to the possible threats the Surf Lodge's non-compliant septic systems pose to the ecological health of this NYS Significant Coastal Fish and Wildlife Habitat.

3 ANNUAL MEETING: IS MILLSTONE SAFE?

CCOM invited the community to explore the nuclear power plant's status and possible danger. Story and photos, pg. 2.

4 KALIKOW DOCK

Scientific and legal arguments against expansion of East Hampton's largest private dock went unheeded in October when State Supreme Court Judge H. Patrick Leis ruled against CCOM's lawsuit seeking to stop Peter Kalikow's additional building in Lake Montauk. The court's rationale: You can't kill what's already dead. Because Mr. Kalikow's earlier construction killed an acre of vital habitat, there was nothing worth preserving and no reason to stop building it even bigger. CCOM fought this fatalistic logic but could not get Judge Leis to issue an order halting construction until the case was resolved. Without a court order, Mr. Kalikow raced to finish his expansion both delaying and denying justice and environmental protections in Lake Montauk.

6 CAROL MORRISON ANNUAL WALK, SHADMOOR STATE PARK

7 RYAN REVETMENT, SURFSIDE AND SHADMOOR STATE PARK

After much testimony and community organizing, CCOM is currently awaiting a written decision that will clarify how the East Hampton Town Zoning Board of Appeals plans to ignore nearly all of the Town's rules prohibiting new "shorehardening" structures (jetties, groins, bulkheads) along the ocean beaches. John Ryan of Surfside has proposed building a 10-foot high, 100-foot long stone wall to deflect stormwater runoff from the bluffs on his property and onto the publicly-owned Shadmoor State Park next door. Without even requiring the preparation of an Environmental Impact Statement, the Board has issued their initial approval. State law prohibits any legal action on the case until after the final written determination is issued.

8 POINT OF WOODS TO LIGHTHOUSE HIKE

The relic forest of Point Woods and ocean bluffs provided backdrop as CCOM Vice President Ed Porco led hikers along five miles of stunning views, military history and diverse ecosystems.

ANNUAL CAROL MORRISON GUIDED WALK



MEET THE CANDIDATES

Just when you were wondering if anyone cared about the upcoming election, 140 "concerned citizens" show up to your Meet the Candidates forum! That's exactly what happened on October 23 when a standing-roomonly crowd packed into the Montauk Firehouse to hear 25 candidates for county executive, county legislator and town positions state their cases for why they should be elected by the good townspeople of East Hampton.

Moderated by CCOM Vice President Peter Lowenstein, candidates at our 41st Annual forum fielded questions from a passionate audience about many quality of life issues in Montauk. Audience members listened intently as candidates tried to explain how they would reconcile
