## SAVE MONTAUK'S WATERS CCOM FLOATING WETLANDS PROJECT MAJOR MILESTONE

Since launching our water quality campaign this summer we have been

very active with ongoing water quality testing and a series of public events at Ditch Plains, Fort Pond House, the Montauk Farmers Market, and the Fall Festival.

We reached a major milestone on Saturday, October 23rd, when CCOM and nearly 45 volunteers worked together to remove our floating wetlands installation from Fort Pond. The 3,000 sq. feet of floating wetlands, a pilot project funded by an East Hampton



Town CPF Water Quality Improvement grant, were installed in May 2021 to remove excess nutrients in Fort Pond that have been fueling seasonal harmful algal blooms.

The islands themselves will be stored for future reuse, and the harvested plants have been donated to the Montauk Community Garden for composting. Samples will be sent to Hofstra University for analysis to quantify nutrient removal capacity. "This project literally took a village," said CCOM President Laura Tooman, "we could not have done it without the help and generosity of our incredible community."

## **SUPERSTORM SANDY 9 YEARS LATER** PROGRESS ON COASTAL ADAPTATION & RESILIENCY PLANNING

October marks the 9th year anniversary of Superstorm Sandy and the devastation caused here in October 2012. Since that time CCOM has been leading the charge to help develop sustainable coastal resiliency planning and serves on the East Hampton Town Coastal Adaptation and Resiliency Planning (C.A.R.P) committee which recently presented a series of long range coastal options for Montauk. NEW MONTAUK GATEWAY PROJECT IMPROVES RESILIENCY

Announced just this week is exciting news about an intergovernmental

partnership to fund the undergrounding of utility lines at the gateway to the hamlet of Montauk. Funding of the estimated \$750,000 cost has been agreed to jointly by NY State and the Town of East Hampton. This project will supplement an ongoing private effort to underground utility lines along Old Montauk Highway with several phases of this effort already having been completed. Read the press
